In his legal practice, Rust concentrates on transactional, governance, regulatory and medical-legal issues affecting healthcare entities and provider organizations, as well as advising such entities on mergers and acquisitions, and contract formation and negotiation. He has participated in briefs to the United States Supreme Court for clients such as the American Medical Association, and provided testimony to the U.S. Congress and several state legislatures on healthcare delivery and managed care.
