Independent Counsel

David Wood and Matthew O'Hanlon will discuss independent or Cumis counsel issues affecting policyholders in all states, with special attention to California. 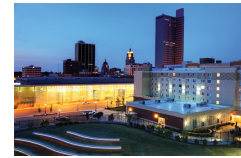

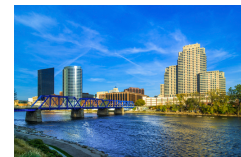
