

His trial work has frequently led to appellate work, including arguing patent cases before the U.S. Court of Appeals for the Federal Circuit, a copyright case before the U.S. Court of Appeals for the Eleventh Circuit, and a publicity rights case before the Indiana Court of Appeals. Todd also represents clients before the Patent Trial and Appeals Board (PTAB) in inter partes review matters.

Apart from his litigation work, Todd also counsels clients on cybersecurity and data protection, privacy, computer and software issues, e-commerce processes, and other business technology matters. As co-chair of the firm's Data Security and Privacy practice, Todd works with clients to evaluate their data security needs, develop comprehensive data security plans, and manage responses to data breaches or other cybersecurity incidents.
