His export controls and sanctions experience is equally comprehensive and includes export classification (ECCN and USML categories), commodity jurisdiction, restricted party screening (SDN, MEU, Entity List, etc.), export licenses, audits and monitorships, voluntary self-disclosures (VSD), and creation of export compliance programs.

He is frequently called upon in cross-border transactions to guide clients through import and export due diligence, and in particular, through the various stages of national security reviews before the Committee on Foreign Investment in the United States (CFIUS), including the filing of joint voluntary notices and declarations.
